Safety Rules and Guidelines to Use the 850 Yard Range

- A. ALL Shooters must have a Qualification Card issued by Bradford Sportsmen's Farm.
- B. You must sign in and out on the 850 Yard Range sheet.
- C. All shots must impact the berm at the base or up to 2/3 of the berm height. Plan your shots accordingly.
- D. No alcoholic beverages are to be consumed prior to or during shooting.
- E. All Shooters must use the same firing line.
- F. Shoot only at your own target, all shots must be perpendicular to the berm.
- G. Do not place targets on the ground at intermediate distances under any circumstances. This will cause bullets to skip off the ground and leave the property.
- H. All intermediate targets must be placed on a stand at sufficient height to ensure that the bullets impact berm (see rule C).
- I. No glass targets are allowed and we ask that you police your area when finished.
- J. No horseplay or unsportsmanlike conduct permitted
- K. While not in use all firearms are to be unloaded with the actions open. When the firing line is cold, a loaded firearm with the safety on is not considered safe.
- L. You must provide your own target stands that meet the regulations above.
- M. All qualified 850-yard range cardholders are considered range officers and we ask that you politely help us enforce the above rules for the safety of all.
- N. Bradford Sportsmen's Farm reserves the right to revise these rules as they deem necessary without prior notice.

Bradford Sportsmen's Farm **Release and Indemnification**

The undersigned, in consideration of admittance as requested by the undersigned to the Bradford Sportsmen's Farm, on behalf of Participant, Participant's heirs, legal representatives and assigns, agrees to and hereby does release Bradford Sportsmen's Farm, their owners, officers, employees, agents, contributors, financial supporters, sponsors, administrators, executors, and assigns (hereinafter respectively and collectively referred to as "Sponsors") from, and jointly and severally agree to indemnify and hold each of Sponsors harmless from and against any and all liabilities, costs, and expenses (including reasonable attorney's fees and expenses of litigation) which they may jointly or severally incur to the Participant, their heirs, legal representatives or assigns, in respect of any claim, suit or cause of action of whatever kind or nature arising from, related to or on account of any Participant's presence at or participation in the Event including, without limitation, any such injury, loss of damage resulting from any failure to perform on the part of any person with whom Sponsors have contracted for goods or services in connection with the Event, any civil commotion, force majeure, act of God or government, or otherwise; and the Participant further agrees to indemnify and hold each of Sponsors harmless from and against any and all liabilities, costs, and expenses (including reasonable attorney's fees and expenses of litigation) which they may jointly or severally incur to any person, Participant's heirs, legal representatives or assigns, in respect of any claim, suit or cause of action of whatever kind or nature on account of any personal injury, loss of health, financial loss, or damage to property directly or indirectly sustained by such person, their heirs, legal representatives or assigns, as a result of the Participant's action, series of actions, or failure to act in or in connection with the Event or otherwise. The undersigned declares that Participant is 18 years of age or over and in good health and agrees that, as a condition to participating in the Event, Participant will obey all applicable laws, written and oral rules, direction, practices and procedures, whether with respect to safety, conduct or otherwise; and in recognition of the danger to which Participant is voluntarily subjected in connection with the Event, hereby knowingly, freely, and voluntarily assumes the risks and waives any rights or cause of action, of any kind whatsoever, arising out of or as a result of such Event activity and participation from which any liability may or could accrue to Sponsors, and covenants never to sue Sponsors on accounts thereof. Participant acknowledges and agrees that no alcoholic beverages or drugs are permitted at Bradford Sportsmen's Farm; that Participant has not imbibed any alcoholic beverage or drug or substance that could impair Participant in any manner whatsoever; the Participant is experienced with the risk and safety rules of shooting sports; that all guns must be left unloaded, breached, or open, except when Participant is in a safe position in a shooting stand or on the shooting line; and that safety eye and ear protection will be worn by Participant at all times when in a shooting area.
