

SPORTING CLAYS RULES & REGULATIONS

- 1. ONE MISTAKE CAN CHANGE YOUR LIFE. WALK AND STAND ONLY ON DESIGNATED TRAILS AND SHOOTING STATIONS. NO ONE IS ALLOWED IN RESTRICTED AREAS OR OFF PATHWAYS AT ANY TIME.
- WHEN NOT ON STATION, YOUR GUN MUST BE EMPTY AND THE ACTION OPEN.
- 3. ONLY ONE SHOOTER ON A STATION AT A TIME.
- 4. LOAD ONLY WHEN ON STATION AND ONLY AFTER THE SHOOTING AREA IS SECURE. KEEP LOADED AND UNLOADED GUNS IN A SAFE DIRECTION AT ALL TIMES. GUN MALFUNCTION! KEEP GUN POINTED DOWN RANGE.
- 5. MAXIMUM NUMBER OF SHELLS IN A GUN TWO (2).
- 6. DO NOT SHOOT AT LIVE ANIMALS OR BIRDS.
- 7. CHILDREN MUST BE UNDER ADULT SUPERVISION AT ALL TIMES.
- 8. NO ONE UNDER THE AGE OF 16 IS PERMITTED TO DRIVE GOLF CARTS OR 4-WHEELERS WITHOUT ADULT SUPERVISION.
- 9. EYE AND EAR PROTECTION ARE REQUIRED.
- 10. ALL EMPTY HULLS ON THE GROUND ARE THE PROPERTY OF THE CLUB, HOWEVER, YOU MAY PICK UP YOUR HULLS BUT NO OTHERS.
- 11. ABSOLUTELY NO ALOCHOLIC BEVERAGES ON THE RANGE.
- 12. WE ARE ON THE HONOR SYSTEM: PLEASE KEEP TRACK OF THE EXTRA TARGETS YOU SHOOT AND ADD THEM INTO YOUR TOTAL WHEN PAYING.

FAILURE TO FOLLOW THESE RULES AND ANY UNSPORTSMAN –LIKE CONDUCT MAY RESULT IN THE SHOOTER BEING ASKED TO LEAVE THE RANGE WITHOUT A REFUND.

TYPES OF TARGET PRESENTATIONS

- 1. SINGLE -YOU MAY SHOOT TWICE AT ANY SINGLE
- 2. REPORT PAIR- (THE FIRST BIRD IS THROWN WHEN YOU CALL PULL, THE SECOND IS THROWN WHEN YOU FIRE AT THE FIRST

(IN THE EVENT THE FIRST BIRD IS THROWN AND YOU ARE UNABLE TO FIRE AT THE SECOND BIRD DUE TO BROKEN TARGET OR GUN MALFUNCTION, THE FIRST BRID IS ESTABLISHED DEAD OR LOST AS SHOT BY THE SHOOTER.

3. TRUE PAIR – BOTH BIRDS ARE LAUNCED SIMULTANEOUSLY. (NOTHING ESTABLISHED IN THE EVENT OF ANY MALFUNCTION.)

Bradford Sportsmen's Farm Release and Indemnification

The undersigned, in consideration of admittance as requested by the undersigned to the Bradford Sportsmen's Farm, on behalf of Participant, Participants heirs, legal representatives and assigns, agrees to and hereby does release Bradford Sportsmen's Farm, their owners, officers, employees, agents, contributors, financial supporters, sponsors, administrators, executors, and assigns (hereinafter respectively and collectively referred to as "Sponsors") from, and jointly and severally agree to indemnify and hold each of Sponsors harmless from and against any and all liabilities, costs, and expenses (including reasonable attorney's fees and expenses of litigation) which they may jointly or severally incur to the Participant, their heirs, legal representatives or assigns, in respect of any claim, suit or cause of action of whatever kind or nature arising from, related to or on account of any Participant's presence at or participation in the Event including, without limitation, any such injury, loss of damage resulting from any failure to perform on the part of any person with whom Sponsors have contracted for goods or services in connection with the Event, any civil commotion, force majeure, act of God or government, or otherwise; and the Participant further agrees to indemnify and hold each of Sponsors harmless from and against any and all liabilities, costs, and expenses (including reasonable attorney's fees and expenses of litigation) which they may jointly or severally incur to any person, Participant's heirs, legal representatives or assigns, in respect of any claim, suit or cause of action of whatever kind or nature on account of any personal injury, loss of health, financial loss, or damage to property directly or indirectly sustained by such person, their heirs, legal representatives or assigns, as a result of the Participant's action, series of actions, or failure to act in or in connection with the Event of otherwise. The undersigned declares that Participant is 18 years of age or over and in good health and agrees that, as a condition to participating in the Event, Participant will obey all applicable laws, written and oral rules, direction, practices and procedures, whether with respect to safety, conduct or otherwise; and in recognition of the danger to which Participant is voluntarily subjected in connection with the Event, hereby knowingly, freely, and voluntarily assumes the risks and waives any rights or cause of action, of any kind whatsoever, arising out of or as a result of such Event activity and participation from which any liability may or could accrue to Sponsors, and covenants never to sue Sponsors on accounts thereof. Participant acknowledges and agrees that no alcoholic beverages or drugs are permitted at Bradford Sportsmen's Farm; that Participant has not imbibed any alcoholic beverage or drug or substance that could impair Participant in any manner whatsoever; the Participant is experienced with the risk and safety rules of shooting sports; that all guns must be left unloaded, breached, or open, except when Participant is in a safe position in a shooting stand or on the shooting line; and that safety eye and ear protection will be worn by Participant at all times when in a shooting area.
